**UVA PROVINCE PROVINCIAL COUNCIL**

**Co-operative Employees Commission Statute No. 1 of 2016 (Amendment) of Uva Provincial Council**

This Statute is imposed to amend the Uva Provincial Cooperative Employees Commission Statute No. 04 of 2010, and,

Incorporated by the Uva Provincial Council, by virtue of the powers vested in the Provincial Councils by the 13th Amendment of the Constitution of the Democratic Socialist Republic of Sri Lanka.

01. This Statute may be cited as the “Uva Provincial Council Co-operative Employees Commission Statute No. 1 of 2016 (amended) and shall come into operation on such date as the Governor of the province may approve or appoint, unless the context requires otherwise.

Amendment to  
Section 5 of main  
statute

02. Uva Provincial Cooperative Employees Commission Statute No. 04 of 2010 (hereinafter referred to as the “main statute”) is hereby amended by the following substitution for sub-sections (1) & (3) of the Section 5 of the said statute.

Content of the  
commission

- (1) The Commission shall be consisting of five (05) members appointed by the Minister-in-charge of Co-operative Affairs of Uva Provincial Council, referred to as the “Minister” hereinafter.
- (3) Three (03) of the members of the Co-operative Employees Commission shall be appointed from the retired government officials who were in a staff grade position, and one of the three should be a person with a sound knowledge in the Co-operative field.

and

Amendment to  
Section 7 of main  
statute

03. Sub-sections (2), (3) and (4) of Section 7 of the Uva Provincial Cooperative Employees Commission Statute No. 04 of 2010 is hereby replaced by the following substitutions.

- (2) Three (3) members shall constitute the quorum for a meeting of the commission.
- (3) If at any meeting only four (04) members of the commission are present and such members are divided in opinion as to the decision to be taken on any question, such question shall be referred to a meeting at which the all five (05) members of the commission are present.
- (4) If at any meeting, at which the five (05) members of the commission are present, and the members of the commission are divided in opinion as the decision to be given on any question, such question shall be decided according to the opinion of the majority of the members, but if the members are equally divided, then, the Chairman shall have a casting vote.

Sinhala text to prevail

In the event of any inconsistency between the Sinhala and Tamil text of this statute, the Sinhala text shall prevail.
